MEDICAL AUTHORIZATION

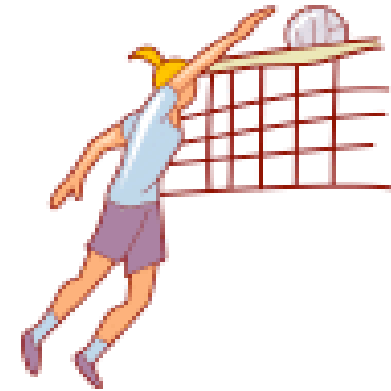
In the event of injury or illness to our child during the above
